PICNIC RESERVATION FORM

The Town of San Anselmo offers six picnic areas that may be reserved. All reservations are processed on a first-come, first served basis. Reservation fee is payable in full at time of reservation. Reservation fees are non-refundable; in case of inclement weather, the fee may be applied to a future reservation. Reservations accepted a maximum of six months in advance.

M.P. Small Group Area
Next to Millennium Playground, recommended for children's events only, maximum capacity: 30 persons. Inflatable jumpers NOT allowed. Amenities: 4 picnic tables, 1 double barbeque. Fee: Res:\$60/3hrs. Non-Res:\$70/3hrs.

M.P. Large Group Area
Located at northeastern side of park (farthest from playground); maximum capacity: 75 persons. Inflatable jumpers allowed, see attachment. Amenities: 6 picnic tables, 2 double barbeques. Fee: Res:\$85/3hrs. Non-Res:\$95/3hrs.

Elders Garden
Serene area located in Millennium Park. Small round tables and benches. 15 people. Fee: Res:\$25/3hrs. Non-Res:\$35/3hrs.

Creek Park Picnic Area
Located in Downtown San Anselmo. Picnic table seats 20 people. Fee: \$75/per hr., \$150 1/2 day (5 hrs). \$250/day (10 hrs), \$400 weekend (F-Sun)

Robson Upper Picnic Area
Located on the upper grounds near Robson House. Maximum capacity 45 persons. Two picnic tables - No BBQ. Fee: Res: \$75/day Non-Res: \$95/day

Robson Lower Picnic Area
Located on the lower lawn of Robson Park. Maximum capacity: 60 persons. Inflatable jumpers NOT allowed. Large picnic tables, 2 dbl. BBQs Fee: Half Day (5 hrs) Res:\$75 Non-Res:\$125 Full Day (10 hrs) Res:\$125/day Non-Res: \$175/day

It is hereby expressly understood and agreed to by the undersigned that any claim asserted against the Town by the undersigned participant, either on behalf of him/her or on behalf of another person, on account of bodily injury, mental disturbance, death or property damage, sustained as a result of, or for any reason connected to the use of Town property, facilities or programs or acts or omissions of Town employees or volunteers pursuant to this registration, will be resolved by submission to arbitration as provided by California law, and not by a lawsuit or resort to court process except as California law provides for judicial review of arbitration proceedings. It is agreed that all claim submission, requirements, procedures, and deadlines and all immunities established by the Government Code or other provision of law will apply, but that the undersigned waives all rights to file a lawsuit and agrees, in lieu thereof, to resolving all claims and disputes through the arbitration process. The Town and the undersigned, by execution of this document, are giving up their constitutional right to have any such dispute decided in a court of law and before a judge or jury and instead are accepting the use of arbitration.
