

April 18th 1910.

The Board of Trustees of the Town of San Anselmo met on Monday the 18th day of April, 1910 pursuant to law for the purpose of canvassing the returns of the general election held in the Town of San Anselmo, on Monday the 11th day of April, 1910. President, W. E. Jones called the meeting to order at eight-twenty (8:20) P.M. There were present Trustees Stratford, Crisp and Jones. Absent, Trustees Tunstead and Robinson. The Clerk of the Board stated he had the returns of said election present and ready to be opened. On motion Trustee Crisp, seconded by Trustee Stratford and carried, the Clerk of the Board was directed to open the envelopes enclosing said returns. And this Clerk, thereupon, in the presence of said Board in open meeting, did open the envelope containing the said returns and did produce the returns of said election.

Upon motion of Trustee Crisp, seconded by Trustee Stratford and carried, it was ordered that this Board proceed to canvass said returns and in accordance ^{with} said motion and in accordance with law this Board in open public meeting proceeded to and did thereupon canvass the returns of said election.

Trustee Stratford moved the adoption of the following order:

Whereupon in open public meeting this Board did proceed in regular manner and according to law to canvass the returns of the election heretofore held in this Town on the 11th day of April, 1910.

Now, therefore, it is ordered that this Board finds and declares the result of said election and of said canvass to be,-

First, that the total number of votes cast in the Town of San Anselmo at said general election is three hundred and twenty-six (326) votes.

That for the office of the members of the Board of Trustees of the Town of San Anselmo for the full term
 Elmer P. Gagon received, one hundred and seventy five votes (175)
 W. S. Whitaker received one hundred and seventy one (171) votes.

E. W. Schraden received one hundred and fifty eight (158) votes.

J. G. Orip received one hundred and fifty one (151) votes.

W. V. Jones received one hundred and eleven (111) votes.

A. W. Quinn received forty seven (47) votes.

That in the office of member of the Board of Trustees of the Town of San Anselmo - for the unexpired term H. J. Stratford received two hundred and five (205) votes.

That for the office of Clerk of the Town of San Anselmo, A. A. Moore received one hundred and eighty five (185) votes.

Arthur W. Stacey received ninety one (91) votes.

C. O. Buckley received forty one (41) votes.

That in the office of Treasurer of the Town of San Anselmo, L. R. S. Holmes received one hundred and eighty two (182) votes.

Joe. H. Leach received one hundred and thirty (130) votes.

That for the office of Marshal of the Town of San Anselmo, Geo. A. Martin received one hundred and seventy nine (179) votes.

David H. P. Turner received one hundred and forty one (141) votes.

And it further appearing to this Board from the canvass of said returns as aforesaid that Chas. R. Gagan, E. W. Schrader and C. S. Whitaker received the highest number of votes cast for the offices of members of the Board of Trustees of the Town of San Anselmo for the full term and that H. J. Stratford received the highest number of votes cast for the office of member of the Board of Trustees of the Town of San Anselmo for the unexpired term and that A. A. Moore received the highest number of votes cast for the office of

Clerk of the Town of San Anselmo and that L. R. S. Holmes received the highest number of votes cast for the office of Treasurer of the Town of San Anselmo and that Geo. A. Martin received the highest number of votes cast for the office of Marshal of the Town of San Anselmo.

Now, therefore, it is by this Board ordered and declared that Chas. R. Gagan, E. W. Schrader and C. S. Whitaker be and they are hereby declared to be elected to the offices of members of the Board of Trustees of the Town of San Anselmo for the ~~full~~ term.

That H. J. Stratford be and he is hereby declared to be elected to the office of member of the Board of Trustees of the Town of San Anselmo for the unexpired term.

That A. A. Moore be and he is hereby declared to be elected to the office of Clerk of the Town of San Anselmo.

That L. R. S. Holmes be and he is hereby declared to be elected to the office of Treasurer of the Town of San Anselmo.

That Geo. A. Martin be and he is hereby declared to be elected to the office of Marshal of the Town of San Anselmo.

It is further ordered that the Clerk of this Board forthwith give official notice to each of said persons of his election. The adoption of the foregoing was seconded by Trustee ^{Stratford} ~~Stratford~~ and carried by the following vote:

Ayes: Trustees Stratford, Crisp and Jones.

Noes: None

Absent: Trustees Tunstead and Robinson.

The newly elected officials of the Town were then sworn in and all affidavits of election subscribed and sworn to.

The new Board being called to order by Pres. W. E. Jones Trustee Stratford placed in nomination W. E. Jones for the Chairmanship of the Board for the ensuing two years. Nomination seconded by Trustee Schrader.

Trustee Whitaker nominated H. J.

Stratford for the Chairmanship of the Board for the ensuing two years. The nomination was declined.

Trustee Stratford moved the nominations closed. Recorded by Trustee Whitaker and carried.

The Clerk put the question for the vote on the nomination of W. E. Jones for Chairman of the Board which carried.

The chair appointed the following committees:

Health and Sanitary Com. W. S. Whitaker Chairman

Trustee Gagon moved: That E. J. Mowring be appointed Attorney for the Town of San Anselmo for the ensuing two years ^{at a monthly compensation of \$25.00 per month.} The motion was recorded by Trustee Stratford and upon being put to a vote was carried by the following vote.

Ayer: Trustees Gagon, Schradu, Whitaker, Stratford and Jones.

Noes - None.

Absent - None.

The Bond of the Clerk was upon motion of Trustee Gagon recorded by Trustee Schradu and carried accepted by the Board and filed with the Chairman.

Trustee Stratford moved to adjourn to meet Thursday evening April 21st 1910. Seconded by Trustee Whitaker and carried.
