MINUTES OF JULY 10TH, 1934.

A regular meeting of the Council of the Town of San Anselmo was held on Tuesday, July 10th, 1934, at the hour of 8 o'clock P.M.

Present: Councilmen Dempsey, Scotford, Dos Reis, Linch and Fusselman.

Absent: None.

Mayor Fusselman presiding.

The minutes of the previous meeting was approved as read.

A petition signed DeWitt Deringer, urging removal of a row of elm trees along the Southerly line of Red Hill Ave., opposite the El Centro Drive In Market, claiming they are a menace to traffic, was read and referred to the Street Committee for recommendation.

A communication signed Alvin Gerlack, relating to the abandonment by the Town of a strip of land formerly used as a roadway, was read and placed on file.

A warrant in the sum of \$100. and payable to Geo. W. Manley was received and the Clerk was instructed to inform Mr. Manley that the Council wishes him to present an itemized bill for services rendered before further action is taken.

The Mayor called upon several members of the Council regarding payment of engineering fees in connection with the proposed playground development under the C.W.A. project. Councilman Scotford told of a rough sketch or plan having been submitted to the Council by the Engineer, which was thereafter referred to the Parks and Housing Committee, although he could not recall ever having seen a set of plans and specifications for such work offered to the Board. He also stated that Mr. Manley was informed that the Town had no funds to pay for his services and that if the project went through, he would have to look to the C.W.A., with whom it was claimed he was registered, for his fee, as the Town was not obligated in any way to meet said expense. Councilman Dempsey reiterated the remarks of Councilman Scotford, also remembered that the Council turned over the very small balance in its relief fund to the Engineer for the purchase of grade stakes. After the meeting Councilman Dempsey claims that a group, in discussing the matter with Manley, believed that the collection of his fees might prove a "gamble". Councilman Dos Reis, who claims to have been present at the meeting at which this matter was discussed, stated that it was

his impression that Manley was informed by Councilman Jordan that the Town would stand the expense of the Engineer's fee in connection with such work. Superintendent of Streets, Wood, stated that Manley was informed that he would have to take chances on the project going through, in order to collect his fee, as the Town was without funds to meet such expense.

Councilman Linch recommended that no street lights be installed on Arroyo Ave. at present, as petitioned for by Mr. Hoppe and others at the last meeting of the Council.

Councilman Dos Reis reported that the Fairfax Council has taken no action on the Contractors' reciprocity agreement to date but was informed that the matter might be acted upon at its next meeting.

Councilman Scotford reported that the Fire Department expected to finish its grass burning program within the next two weeks, and asked that he may be given authority to purchase two rectifiers for the Department.

Upon motion of Councilman Dempsey, the Chairman of the Fire Committee was authorized to purchase two recifiers at a price of \$25. apiece. Motion was seconded by Councilman Scotford and carried by the following vote:

Upon motion of Councilman Dempsey, Warrants Nos. 643 to 697, incl., also Warrants No 703, be paid out of the 1933-34 funds, and Warrants. Nos. 698 to 702, incl., also Warrants Nos. 704 to 707, incl., be paid out of the 1934-35 funds.

~~Upon motion of Councilman Dos Reis, the resignation of Robert W. Harrison, as City Attorney, of the Town of San Anselmo was asked for. There being no second to said motion, the matter was closed.~~

Mr. Oglesby, a former engineer of the Town of San Anselmo, appeared before the Council, asking that permission be granted him to borrow the tracings of all subdivisions within the corporate limits of the Town, and in return would bring the Town Block Books up to date. After some discussion the Council was informed that very likely such tracings were in possession of Mr. Manley or the Bashful Smith Printing Co. of San Francisco, and that in reality they were the property of the Town and worth from \$600. to \$1200, and should be on file in the Town Hall.

Upon motion of Councilman Scotford, the Clerk was instructed to notify Mr. Manley to return or cause to be returned the tracings in question. Motion was seconded by Councilman Dempsey and carried by the following vote:
