Councilman Dos Reis reported on the Lansdale School traffic signal matter and recommended that the claim of Mr. Cerf be referred to the Police Committee and the Town Attorney for settlement.

Councilman Dos Reis introduced a resolution declaring intention of the Council of the Town of San Anselmo to grant a franchise to the Pacific Gas & Electric Co. for the privilege of distributing electricity throughout the Town and moved its adoption. Motion was seconded by Councilman Linch and carried by the following vote:

Councilman Dempsey introduced a similar resolution concerning a franchise to the same Company for the distribution of gas, and moved its adoption. Motion was seconded by Councilman Scotford and carried by the following vote:

Mr. Sloan, representing the P.G. & E. Co. stated that the Company will co-operate with the Town in the matter of cost of publishing the neces-

sary Ordinance authorizing the granting of such franchises.

Upon motion of Councilman Scotford, the \$2500.00 bond of John G. Reynolds was cancelled. Motion was seconded by Councilman Dempsey and carried by the following vote:
