On motion on Councilman Millard, seconded by Councilman Carroll, and unanimously passing, Mr. Arnett was given until Tuesday, December 13th to remove an abandoned structure on his property in the Bush Tract.

The Clerk was instructed to inform the Supervisor's Health Survey Comnittee that Councilman White was appointed to represent the Town of San Anselmo at the meeting to be held in the Court House on Friday, October 28th at 8 o'clock P.M.

A letter of thanks was received from the Morningside Court Improvement Club for the Council's co-operation in clearing the creek which runs through the Court.
