- THE LARGE TREES ON ROSS AVENUE and the request that the City arrange to have the same pruned back for safety and beauty was the subject of a petition by J. F. Benzing and several others. This was referred to Street Commissioner Miller.
- REPAIRING SAN ANSELMO AVENUE OVER THE CUT FOR THE NEW WATER MAINS; the work having been done under the supervision of the City Engineer and said work having his approval, upon the motion of Councilman Miller, seconded by Councilman Smith, it was duly passed and adopted that the work be approved by the City.
- GRADE ON UNNAMED 40 FOOT ROADWAY running westerly from Butterfield Road approximately 500 feet north of Arroya Avenue
 was the subject of a request from the Marin Municipal Water

- EXACT LOCATION OF THE SAN RAFAEL*SANANSELMO CITY LIMITS LINE

 Was discussed and City Engineer Siemer was requested to

 work with San Rafael City Engineer Oglesby to determine

 and map the exact location.
- GARBAGE COLLECTION SERVICE and the findings of the Committee

 appointed to study this problem was reported upon by

 Councilman Love. He reported that the requirements of

 the ordinance were necessary for proper control and policing but that the official collector should enforce collection of his accounts to the end that none should remain beyond one year. Considerable audience discussion developed in the matter, revolving around the right of
