MINUTES OF THE REGULAR MEETING OF THE SAN ANSELMO CITY COUNCIL HELD NOVEMBER 9th 1960
PRESENT COUNCILMEN - Rouse, Smith, Little, Reichmuth, Franchini

Mayor Franchini, presiding

City Administrator brought up matter of Cedar Development School - Bryant McCarthy spoke on behalf of Cedars School - Mr. Benedict represented (46) property owners of Sequoia Park who are objecting to the use of Sequoia Park as access to property of Cedar's. After lengthy discussion Councilman Rouse moves a representative, The City Administrator appear before the Board of Supervisors tomorrow, that it is the recommendation of the City of San Anselmo that a condition for the granting of a Use Permit for the Cedar Development School on property defined, that Sequoia Park and Grove Hill, city streets of San Anselmo be utilized as an emergency access only when primary road is in a physically impassable condition. Councilman Little seconds same. Passed unanimously

FRED KERR, auditor presented annual audit report - Mayor asked Mr. Kerr to prepare a report for next Tuesday's meeting on status of accounting records. (X)

ENGR SURVEY & REPORT - Councilman Little moves to hire Wilsey & Ham accept their proposal in the amount of \$12,800. Councilman Rouse seconds same on basis of letter of October 1960. Motion passed on following vote:

City Administrator recommends hiring of Mr. Hearn as city mechanic at \$458.00 per month. Councilman Little moves approval of above on recommendation of City Administrator same not to be under civil service. Councilman Reichmuth seconds same.
