BACKGROUND

The Town's contract for refuse and recycling services with Marin Sanitary Service expires on January 31, 2009. At the Town Council meeting of March 25, 2008, Councilmembers Barbara Thornton and Ford Greene were appointed to a subcommittee to assist with the contract negotiations. Council also directed staff to initiate a process whereby two community members would join the subcommittee.


