SUBJECT: Appointments to the Board of Review, Planning Commission and Quality of Life Commission

RECOMMENDATION

The Quality of Life Commission has a membership of 7 seats. The Commission has one (1) vacancy expiring April, 2009. Jon Elam was interviewed for this position.




