Hello,

The road between Sorich Park and Salinas will be completely CLOSED to all traffic tomorrow 8AM-6PM.

From Salinas to SFD:

San Francisco Blvd will be closed to through traffic. There will be periodic closures at various locations; however, we will get folks through the site with 15-minute delays.

Due to a small setback on Friday, we will be working a couple of hours of overtime tomorrow.

Due to the various subcontractors involved, we were not able to issue notifications of the revised hours for the rest of the week. The Town and Ghilotti will meet tomorrow to review the remaining schedule.

Please remember to come to a complete stop at stop signs unless being flagged through the intersection.

Please continue to keep your speed down to 5 MPH (10MPH max). Thank you for keeping the crews safe by going slow and paying attention.

If you live north of Veterans, please use the Pasadena detour as much as possible. This will keep construction efficient and dust down. As construction continues dust should be reduced further.

Ghilotti has coordinated directly with the post master. If you do not receive mail please let us know.

We have had some questions about water. The contractor has not worked on the water system at all. MMWD did work on a small number of services. In those instances, it is likely that sediment within the lines was stirred up when the water was turned back on. This is normal. Please run the water for a few seconds until it clears. If you have any concerns, please contact MMWD.

So,

If you live **between Santa Cruz and #212**, please enter and exit at the Santa Cruz intersection

If you live **between #219 and Salinas**, please use the detour to approach from the Salinas side.

Alternatively, please park on side streets. \*Remember to leave 12' clearance for fire truck access.

If you live between Santa Cruz and Sorich Park, please try to minimize the number of trips you make back and forth on San Francisco tomorrow. We expect some traffic and we understand the need to have access. However, as you may have noticed today, each car needing access over the trenches will slow production and with the amount of traffic that we have, it will add up to a significant difference.

Updating their utility data and searching for conflicts to protect (small crews digging small holes in the road)
