

RESOLUTION NO. 4369

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SAN ANSELMO APPROVING
MAXIMUM CUSTOMER RATES FOR SOLID WASTE, RECYCLABLE AND ORGANIC WASTE
COLLECTION BY MARIN SANITARY SERVICE TO TAKE EFFECT ON JANUARY 1, 2021**

WHEREAS, Marin Sanitary Service ("MSS") provides residential, commercial and multi-family solid waste services, including garbage, recycling and organics collection and processing; and

WHEREAS, MSS also provides garbage, recycling, and organics pick-up for Town of San Anselmo ("Town") facilities, parks, and sidewalk receptacles downtown and throughout San Anselmo; and

WHEREAS, at its meeting of November 26, 2019, the Town Council adopted a resolution approving an Amended and Restated Collection Agreement with MSS for provision of these solid waste services for a ten-year period beginning on January 1, 2020 ("Amended and Restated Franchise Agreement"); and

WHEREAS, MSS proposed an increase in Customer Rates for Solid Waste, Recyclable, and Organic Waste Collection to take effect on January 1, 2021, as reflected in Exhibit A hereto; and

WHEREAS, the Town properly published notice of the proposed rate increase as required by law; and

WHEREAS, at its December 8, 2020, meeting the Town Council conducted a duly noticed public hearing to consider the proposed maximum rates and the Council reviewed the staff report and oral and written evidence presented at the hearing.

**NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF SAN ANSELMO DOES
RESOLVE AS FOLLOWS:**


Section 1. Environmental Review. The Town Council finds that adoption of this resolution increasing MSS rates is not a "project" under the California Environmental Quality Act (CEQA), because it does not involve an activity which has the potential to cause a direct or reasonably foreseeable indirect physical change in the environment. (Cal. Pub. Res. Code § 21065). Moreover, the Town Council finds that even if it were considered a project, adoption of the resolution is exempt from the CEQA under CEQA Guidelines section 15061(b)(3), because it can be seen with certainty that there is no possibility that approval of the customer rates may have a significant effect on the environment.

Section 2. Adoption of Rates. The Town Council hereby establishes the maximum Customer Rates for Solid Waste, Recyclable, and Organic Waste Collection by Marin Sanitary

Service as reflected in Exhibit A, which is incorporated herein by reference. The rates shall be effective on January 1, 2021.
