

ORDINANCE NO. 55

FIXING THE RATE OF TAXATION FOR THE FISCAL  
YEAR 1909-10.

The Board of Trustees of the Town of San Anselmo, do  
ordain as follows:

Section 1: The rate of taxation for municipal purposes for  
the fiscal year commencing July 1st, 1909, and ending June 30th,  
1910, upon each One hundred Dollars (\$100.00) of assessed valua-  
tion of all real and personal property within said Town, be, and  
the same is hereby, fixed at the following rates, and for the fol-  
lowing named funds:

Sprinkling Fund Eleven and  $\frac{1}{2}$  Cents ( $\$0.11\frac{1}{2}$ ) on  
each One hundred Dollars (\$100.00).

Lighting Fund Eighteen and  $\frac{2}{3}$  cents ( $\$0.18\frac{2}{3}$ ) on  
each One hundred Dollars (\$100.00).

Salary Fund Ten and  $\frac{1}{2}$  Cents ( $\$0.10\frac{1}{2}$ ) on  
each One hundred Dollars (\$100.00).

Fire Fund Eleven and one fourth cents ( $\$0.11\frac{1}{4}$ ) on  
each One hundred Dollars (\$100.00).

Road Fund Nine and three fourths cents ( $\$0.09\frac{3}{4}$ ) on  
each One hundred Dollars (\$100.00).

General Fund Thirteen and one half Cents ( $\$0.13\frac{1}{2}$ ) on  
each One hundred Dollars (\$100.00).

Section 2: That Seventy-five Cents (\$0.75) on each One hun-  
dred Dollars (\$100.00) of the assessed valuation of all real and  
personal property within said Town, be, and the same is hereby,  
fixed as the total tax for municipal purposes for said fiscal  
year.

Section 3: The rate of taxation for said fiscal year, for  
the payment of the interest and redemption of bonds for the  
improvement of roads and the construction and acquisition of a  
right of way to the Bush Tract, is hereby fixed at Thirty-two  
Cents ( $\$0.32$ ) upon each One hundred Dollars (\$100.00) of as-

assessed valuation of all real and personal property within said Town.

Section 4: That said Thirty-two Cents (\$0.32) on each One hundred Dollars (\$100.00) of assessed valuation be paid into a fund known as "Municipal Improvement Bond Sinking Fund."

Section 5: The rate of taxation for said fiscal year, for the payment of the interest and redemption of bonds for building, constructing, extending and completing a sewer system in sewer District No. 1 of the Town of San Anselmo, as divided and constituted by Ordinance No. 47, passed and adopted August 4th, 1909, is hereby fixed at Fifty-eight Cents (\$0.58) upon each One hundred Dollars (\$100.00) of assessed valuation of all real and personal property within said Sewer District No. 1.

Section 6: That said Fifty-eight Cents (\$0.58) on each One hundred Dollars (\$100.00) of assessed valuation, be, and the same is hereby, levied, exclusively, upon all real and personal property within said Sewer District No. 1, and that said Fifty-eight Cents (\$0.58) on each One hundred Dollars (\$100.00) be paid into a fund known as "Municipal Improvement Bond Sinking Fund of Sewer District No. 1".

Section 7: This Ordinance shall take effect and be in force from and after its passage and approval.
