

Ordinance *22*
**REGULATING PLUMBING AND SEWER CONNECTIONS
 AND THE USE OF THE SAME IN THE TOWN OF
 SAN ANSELMO.**

The Board of Trustees of the Town of San Anselmo do
 ordain as follows:

Section 1. Every residence building in said Town of San Anselmo now in use, or which may hereafter be built, shall have a complete system of plumbing and drainage constructed, connecting with the sewers in said Town. All sewerage, consisting of the ordinary discharge from water-closets, urinals, wash-stands, bathtubs, laundry-tubs, kitchen sinks, and all other similar fixtures, shall be disposed of through said system and sewers, and in no other way. No rain waters from roofs, courts, or areas, or other surface or surface drains, shall be allowed to discharge into said system or said sewers. No garbage, ashes, sand, rags, wood, large paper, or any other refuse whatever, except sewerage, shall be deposited in said system or in any of the sewers of said Town.

Section 2. No person, firm, company or corporation shall connect a system of plumbing and drainage with the said sewers, or discharge any sewerage therein, until said plumbing and the connection to said sewers has been inspected by the authorized Inspector of the Town.

Section 3. Any person, firm, company or corporation that violates any of the provisions of this Ordinance, or neglects or refuses to comply with the provisions thereof, shall be deemed guilty of a misdemeanor, and, upon conviction thereof, shall be punished by a fine not exceeding Three hundred Dollars (\$300.00), or by imprisonment, for not more than Three (3) months, or by both such fine and imprisonment.

Section 4. This ordinance shall take effect and be in force from and after the ~~6th~~ day of May, 1911.
