

ORDINANCE NO. 9a

PROVIDING FOR OFFICIAL BULLETIN BOARDS AND
FOR THE PROTECTION OF THE SAME.

The Board of Trustees of the Town of San Anselmo do ordain
as follows:

Section 1: Official bulletin boards of the Town of San Anselmo, upon which are to be posted all notices, advertisements, ordinances, or other papers, documents, or writings, required to be posted pursuant to law, or the order of the Board of Trustees of said Town of San Anselmo, are hereby established at the following places, to-wit: One (1) at or near the Council Chamber Door of said Board of Trustees; One (1) at the intersection of the Red Hill and Ross Landing Road with Ross Avenue; One (1) at the Ross Valley Park bridge; and One (1) at or near ~~the intersection of~~ Yolanda Station.

Section 2: It shall be unlawful for any person to injure, disfigure, deface, mutilate, or destroy, any official bulletin board of the Town of San Anselmo.

Section 3: It shall be unlawful for any person, unless duly authorized by the Board of Trustees of the Town of San Anselmo, to alter, injure, deface, mutilate, obliterate, remove, tear down, or destroy, any notice, advertisement, ordinance, or other paper, document, or writing, affixed to, or posted upon an official bulletin board of the Town of San Anselmo, pursuant to law, or the order of the Board of Trustees of the Town of San Anselmo, or affix thereto, or post thereon, any notice, placard, bill poster, advertisement, sign, or other paper, document, or writing.

Section 4: Any person violating any of the provisions of this Ordinance shall be guilty of misdemeanor, and, upon conviction thereof, shall be punished by a fine not exceeding Twenty-five Dollars (\$25.00), or by imprisonment in the County Jail not exceeding Ten (10) days, or by both such fine and imprisonment.

Section 5: This Ordinance shall take effect and be in force immediately from and after its passage.
