

AN ORDINANCE RELATING TO THE CONSTRUCTION,  
REMOVAL, SAFETY AND SANITARY CONDITIONS OF  
DAMS OR IMPOUNDING OF WATERS IN CREEKS  
OR STREAMS.

The Board of Trustees of the Town of San Anselmo do  
ordain as follows:-

Section 1.- It shall be unlawful after the passage of  
this ordinance for any person or persons, firm, co-partnership or  
corporation to dam or impound any water or waters, flowing in any  
Creek or stream in the Town of San Anselmo, without a permit from  
the Board of Trustees. No such permit shall authorize any dam or  
impounding of any such water or waters earlier than June 1st or  
for a period later than August 15th in any year, at which last named  
date, any such dam or impounding must be removed.

Section 2.- It shall be the duty of the Town Marshal to  
examine and report to the Board of Trustees upon the safety of any  
dam or impounding of any such waters and it shall be the duty of  
the Health officer to examine and report to the Board of Trustees  
any unsanitary conditions of any such dam or impounding, and the  
Board of Trustees may make any order it deems necessary or proper  
and cause a copy thereof to be posted at such dam or place of im-  
pounding, and unless such order shall be complied with, within the  
time therein specified, said dam or impounding shall be summarily  
removed under the direction of the Town Marshal. If any such dam  
or impounding be maintained for a period longer than provided for  
by such permit of the Board of Trustees, it shall be removed by  
direction of the Town Marshal, summarily.

Section 3.- Subject to the limitations and provisions  
of this ordinance the Board of Trustees may grant a permit for the  
maintenance of any dam or impounding of any such water or waters  
which was made before the passage of this Ordinance, which shall  
state the last day for the current year when such dam can be  
maintained.

Section 4.- Any person or persons, firm, co-partnership  
or corporation violating any of the provisions of this ordinance  
shall be guilty of a misdemeanor and upon conviction thereof  
shall be punished by a fine not exceeding Fifty (\$50.00) Dollars

or by imprisonment in the County Jail for a period not exceeding twenty-five (25) days or by both such fine and imprisonment.

Section 5.- All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 6.- This ordinance shall take effect and be in force thirty (30) days from and after its passage and adoption.
