

ORDINANCE NO. 204

AN ORDINANCE REPEALING AN ORDINANCE ENTITLED, "AN ORDINANCE PROVIDING FOR THE INCURRING OF A BONDED INDEBTEDNESS FOR THE TOWN OF SAN ANSELMO, COUNTY OF MARIN, STATE OF CALIFORNIA, IN THE SUM OF THIRTY THOUSAND DOLLARS, IN GOLD COIN OF THE UNITED STATES OF AMERICA, TO PAY THE COST OF CERTAIN PUBLIC MUNICIPAL IMPROVEMENTS OF SAID TOWN, AND PROVIDING FOR THE ISSUANCE OF BONDS EVIDENCING SUCH INDEBTEDNESS." BEING ORDINANCE NO. 203 OF THE TOWN OF SAN ANSELMO, FINALLY PASSED AND ADOPTED ON THE 21ST DAY OF OCTOBER, 1929.

The City Council of the Town of San Anselmo do
ordain as follows:

Section 1. Ordinance No. 203 of the City Council of the Town of San Anselmo, finally passed and adopted on the 21st day of October, 1929, being an ordinance entitled, "An ordinance providing for the incurring of a bonded indebtedness for the Town of San Anselmo, County of Marin, State of California, in the sum of Thirty Thousand Dollars, in gold coin of the United States of America, to pay the cost of certain public municipal improvements of said town, and providing for the issuance of bonds evidencing such indebtedness." is hereby repealed.

Section 2. This ordinance shall be forthwith entered in the Ordinance Book of said Town and shall take effect upon its final passage and approval. This ordinance shall be published once in the "Marin Herald", a newspaper of general circulation printed and published in the Town of San Anselmo, being the official newspaper of said town.
