1 AN ORDINANCE RELATING TO THE CARE AND EXPENDITURE OF MONEYS RE-  
2 CEIVED FROM THE STATE OF CALIFORNIA UNDER THE PROVISIONS OF ARTI-  
3 CLE 5, CHAPTER 1, DIVISION 1 OF THE STREETS AND HIGHWAYS CODE.


5 The City Council of the Town of San Anselmo does ordain as  
6 follows:

7 SECTION 1: To comply with the provisions of Article 5 of  
8 Chapter 1 of Division 1 of the Streets and Highways Code, with  
9 particular reference to the amendments made thereto by Chapter  
10 642, Statutes of 1935, there is hereby created in the City Treas-  
11 ury a special fund to be known as the "Special Gas Tax Street Im-  
12 provement Fund,"

13 SECTION 2: All moneys received by the Town from the State  
14 of California under the provisions of the Streets and Highways  
15 Code for the acquisition of real property or interest therein for,  
16 or the construction, maintenance or improvement of streets or  
17 highways other than State highways, shall be paid into said fund.

18 SECTION 3: All moneys in said fund shall be expended exclus-  
19 ively for the purposes authorized by, and subject to all of the  
20 provisions of Article 5, Chapter 1 Division 1 of the Streets and  
21 Highways Code:

22 SECTION 4: This ordinance shall be published once within  
23 fifteen days after its final passage in the "Marin Herald" a  
24 weekly newspaper printed, published and circulated in the Town  
25 of San Anselmo, and shall be in full force and effect thirty days  
26 from and after its final passage.
