ORDINANCE NO: 250

AN ORDINANCE CREATING A PLANNING COMMISSION FOR THE TOWN OF SAN ANSELMO, WITH MEMBERSHIP, POWERS AND DUTIES AS PROVIDED BY STATE LAW

THE CITY COUNCIL OF THE TOWN OF SAN ANSELMO DOES ORDAIN AS FOLLOWS:

SECTION ONE: There is hereby created a PLANNING COMMISSION in and for the TOWN OF SAN ANSELMO, pursuant to the provisions of an act of the Legislature of the State of California, to-wit: Act number 5211B of the General Laws of the State of California, Statutes of 1929, page 1805, approved June 17th, 1929, as amended. Said Planning Commission shall consist of nine members. Six of said members shall be appointed by the Mayor of the Town of San Anselmo with the approval of the City Council. The Mayor, City Engineer, and City attorney, shall be ex-officio members of said commission.

SECTION TWO: Of the members of the commission first appointed, two shall be appointed for the term of one year; two for the term of two years; one for the term of three years; and one for the term of four years, from and after their respective appointments. Their successors shall be appointed for the term of four years. If a vacancy shall occur, otherwise than by expiration of term, it shall be filled by appointment for the unexpired portion of the term. The terms of ex-officio members shall correspond to their respective official tenures. All members of said commission shall serve without compensation.

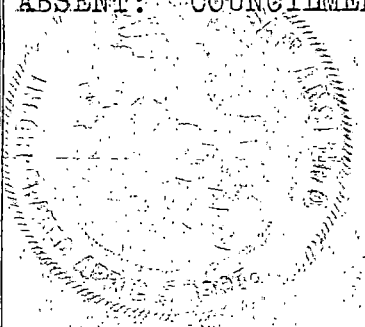
SECTION THREE: The planning commission shall elect a Chairman from among its appointed members for the term of one year. It shall adopt rules for the transaction of business and shall keep a record of its proceedings and of all resolutions, transactions, findings and determinations, all of which shall be public records. The

1 Commission may appoint such officers and employees as it may deem nec-  
2 essary for its work, and they shall hold their office or employment  
3 at the pleasure of the commission. Said Planning Commission shall  
4 in all other respects perform all of the duties and may exercise all  
5 of the powers and privileges specified and provided for in or inci-  
6 dental to said act of the Legislature hereinabove referred to, which  
7 said Act is hereby incorporated by reference in this ordinance as fully  
8 and completely and to the same extent as if herein fully set forth.

9           SECTION FOUR: This ordinance shall be published ~~one~~ in the  
10 San Anselmo Herald, a weekly newspaper of general circulation, pub-  
11 lished and circulated in the Town of San Anselmo, and hereby design-  
12 ated for that purpose, and shall take effect and be in force thirty  
13 days after its final passage and adoption.

14           THE FOREGOING ORDINANCE was duly and regularly introduced at  
15 a regular adjourned meeting of the CITY COUNCIL of the Town of San  
16 Anselmo held in the said Town on the 15th day of February, 1938, and  
17 was thereafter at an adjourned regular meeting held in said Town on  
18 the 8th day of March, 1938, duly passed and adopted  
19 by the following vote:
