AN ORDINANCE AMENDING ORDINANCE
NO. 207 ENTITLED "AN ORDINANCE
REGULATING TRAFFIC UPON THE PUBLIC
STREETS OF THE TOWN OF SAN ANSELMO
AND REPEALING ALL ORDINANCES IN-
CONSISTENT HEREWITH" BY THE ADDI-
TION THERETO OF TWO NEW SECTIONS
NUMBERED 34-a and 35-a

The City Council of the Town of San Anselmo does ordain as follows:

Section 1. Two new sections to be known as Sections 34(a) and 35(a), respectively, are hereby added to Ordinance No. 207, entitled "An Ordinance Regulating Traffic upon the Public Streets of the Town of San Anselmo and Repealing All Ordinances Inconsistent Herewith", said new sections to read as follows:

Section 34(a) - Whenever parallel parking is designated upon the surface of any paved street by lines at right angles to the curb with cross bar, or bars parallel with the curb, the space between such right angle lines shall designate and represent an individual parking space or stall, and any person stopping, standing or parking any motor vehicle upon the area of any street so marked shall stop, stand or park such motor vehicle with the two right hand wheels thereof not more than one foot from the regularly established curb line and in the center of such designated parking space or stall, and any person stopping, standing or parking a vehicle in such areas contrary to the provisions of this section, shall be guilty of a misdemeanor.

Section 35(a) - It shall be the duty of the Chief of Police of the Town of San Anselmo to appropriately mark and set off, in accordance with his sole judgment, by signs and ground markings, suitable stalls and directional information for the parking of motor vehicles in the public parking lots of the Town of San Anselmo, and any person or persons operating, driving, or parking, stopping or standing, motor vehicle in violation of, or contrary to, any such sign or marking, shall be guilty of a misdemeanor.

Section 2. The foregoing ordinance shall, within fifteen (15) days of its final passage and adoption, be published once in the San Anselmo Herald, a weekly newspaper of general circulation, published and circulated in the Town of San Anselmo, and hereby designated for that purpose, and shall be in full force and effect thirty (30) days after its final passage and adoption.
