ORDINANCE NO. ~~243~~ 373

AN ORDINANCE AMENDING ORDINANCE NO. 250 OF THE TOWN OF SAN ANSELMO ENTITLED "AN ORDINANCE CREATING A PLANNING COMMISSION OF THE TOWN OF SAN ANSELMO WITH MEMBERSHIP POWERS, AND DUTIES AS PROVIDED BY STATE LAW," BY INCREASING THE NUMBER OF MEMBERS, EXCLUSIVE OF EX-OFFICIO MEMBERS, FROM SIX TO SEVEN

THE CITY COUNCIL OF THE TOWN OF SAN ANSELMO DOES ORDAIN AS FOLLOWS:

SECTION 1: The second, third and fourth sentences of Section 1. of Ordinance No. 250 is hereby amended to read as follows: Said commission shall consist of seven members. The said seven members shall be appointed by the Mayor with the approval of the City Council. The Mayor and City Engineer shall be ex-officio members of said commission without voting rights.

SECTION 2: A new section numbered 1A is hereby added to Ordinance No. 250 to read as follows: By resolution the City Council may appoint advisory members, who shall be city officers or employees or members of the City Council to advise the Planning Commission. The advisory members shall be without voting rights.

SECTION 3: Section 2. of Ordinance No. 250 is hereby amended by adding thereto the following:

The seventh member of the Planning Commission shall serve for a term of three (3) years from and after the date of his appointment and after said term of three (3) years his successor shall be appointed for a term of four (4) years.

SECTION 4: The amendments herein to Ordinance No. 250 are made pursuant to Sections 65090 to 65857 inclusive of the Government Code of the State of California (Statutes of 1953 Chapter 1355) which said provisions are hereby referred to and

made a part of this Ordinance by such reference as fully and effectively as though set forth herein in full text.


SECTION 5: This Ordinance shall become effective thirty (30) days from and after its final passage and adoption.

SECTION 6: This Ordinance shall be published once within fifteen (15) days after its passage in the SAN ANSELMO TIMES, a weekly newspaper of general circulation published and circulated in the Town of San Anselmo, which said newspaper is hereby designated for that purpose.


The above and foregoing Ordinance No. ~~647~~³⁷³ was read, introduced and passed at a regular meeting of the City Council of the Town of San Anselmo, held on Tuesday, the 14th day of September, 1954, and was thereafter at a Regular meeting of said City Council, held in said Town of San Anselmo, on the 19th day of October, 1954, duly passed and adopted by the following vote:
