CITY OF SAN ANSELMO

ORDINANCE NO. 532

AN ORDINANCE ADOPTING THE 1964 EDITION OF THE UNIFORM PLUMBING CODE OF THE WEST COAST PLUMBING OFFICIALS ASSOCIATION, REGULATING THE CONSTRUCTION, REPAIR AND ALTERATION OF PLUMBING AND SEWERS IN THE CITY OF SAN ANSELMO: PROVIDING FOR PERMITS, FEES, PENALTIES AND AMENDING TITLE 9, CHAPTER 6, ARTICLES 2 AND 4 OF THE SAN ANSELMO MUNICIPAL CODE, AND REPEALING CERTAIN SECTIONS THEREOF.

THE CITY COUNCIL OF THE CITY OF SAN ANSELMO DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1. TITLE 9, CHAPTER 6, ARTICLES 2 and 4 of the San Anselmo Municipal Code are hereby amended as follows:

SECTION 9-6.203 (b) is amended as follows:

"(b) Any work which qualifies for the exemption provided in Sections 7040 to 7053, Article 3, Chapter 9, Division 3 of the Business and Professions Code of the State of California, is also exempt from licensing under this code."

SECTION 9-6.203 (c) is hereby repealed.

SECTION 9-6.208 is hereby amended to read as follows:

"(a) Before any permit required by this Chapter is issued, the applicant therefor shall pay to the Plumbing Inspector the inspection fees for each building or structure as set forth in the following schedule:

SCHEDULE OF PLUMBING FEES

For issuing each permit \$ 2.00

In addition:

For each plumbing fixture or trap or set of fixtures on one trap (including water, drainage piping and backflow protection therefor)	1.50
For each septic tank or house sewer	5.00
Chemical toilet	3.00
For each private sewage disposal system	10.00
For each water heater	1.50

For each individual waste pre-treatment interceptor, including its trap and vent, excepting kitchen type grease interceptors functioning as fixture traps	\$ 1.00
For installation, alteration or repair of water piping and/or water treating equipment	1.50
For repair or alteration of drainage or vent piping	1.50
For each lawn sprinkler system on any one meter including backflow protection devices therefor	2.00
For vacuum breakers or backflow protective devices on tanks, vats, etc., or for installation on unprotected plumbing fixtures including necessary water piping:	
One (1) to five (5)	2.00
Over five (5) each30
For each gas piping system of one to five outlets	1.50
For each gas piping system of six or more outlets, per outlet30
For each swimming pool:	
Public:	20.00
Private:	10.00
Minimum fee for any permit for work requiring inspection:	2.00"

"(b) Where work for which a permit is required by this code is started prior to obtaining said permit, the fees above specified shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of this code in the execution of the work nor from any other penalties prescribed herein."

SECTION 9-6.403 is hereby amended as follows:

"The 1964 Edition of the Uniform Plumbing Code, as published by the West Coast Plumbing Officials Association, is hereby adopted by reference with the following revisions:

(a) Part One, 'Administration' of the 1964 Edition is hereby deleted, and the provisions of this chapter

shall be substituted.

(b) Part Two, 'Qualifications of Plumbers' is hereby deleted, and anyone who possesses a valid Plumbing License, C-36, or Sewer, Sewage Disposal, Drain, Cement Pipe Laying License C-42, issued by the Contractor's License Board of the State shall be deemed to be qualified.

(c) Appendix D. 'Rainwater Systems' is hereby deleted, and Appendix D, 'Swimming Pools' is substituted therefor and made a part of this chapter. (See Article 5)

Exception: The exception set forth in Section 9-6.401 of this article shall apply fully to the Uniform Plumbing Code."

SECTION 9-6.404 is hereby repealed.

SECTION 2. This Ordinance shall be published once in full within fifteen (15) days of its final passage and adoption in the Independent-Journal, a newspaper of general circulation printed and published in the ^{County of} ~~City~~ Maine of ~~San Anselmo~~, and shall be in full force and effect thirty (30) days from and after final passage.
