SECTION 1. That an amendment to the Contract between the City Council

Administration, California Public Employees' Retirement System is hereby authorized, a copy of said amendment being attached hereto, marked "Exhibit A", and by such reference made a part hereof as though herein set out in full.

SECTION 2. The Mayor of the

AMENDMENT TO CONTRACT BETWEEN THE
BOARD OF ADMINISTRATION
PUBLIC EMPLOYEES' RETIREMENT SYSTEM
AND THE

CITY COUNCIL
OF THE
CITY OF SAN ANSELMO

The Board of Administration, Public Employees' Retirement System, hereinafter referred to as Board, and the CITY COUNCIL of the CITY OF SAN ANSELMO, hereinafter referred to as Public Agency having entered into a contract under the date of April 24, 1959, effective July 1, 1959, and as amended effective January 1, 1964, November 1, 1966, December 1, 1968, and December 1, 1972, which provides for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

A. The following subparagraph shall be added to Paragraph 8 of said contract:

8(c) Section 20952.5 (providing for age 50 as the minimum voluntary retirement age for local safety members with benefit payments commencing prior to age 55 subject to actuarial discount).

B. This amendment shall be attached to said contract and shall become effective on the 1st day of September, 1973.
