does ordain as follows:

SECTION 1. That an amendment to the Contract between the City Council
(Name of Governing Body) of the City of San Anselmo
(Name of Public Agency) and the Board of Administration, California Public Employees' Retirement System is hereby authorized, a copy of said amendment being attached hereto, marked "Exhibit A", and by such reference made a part hereof as though herein set out in full.

SECTION 2. The Mayor of the City Council of the City of San Anselmo
(Title of Presiding Officer) (Name of Governing Body) hereby authorized, empowered, and directed to execute said amendment for and on behalf of said Agency.

SECTION 3. This Ordinance shall take effect 30 days after the date of its adoption, and prior to the expiration of 15 days from the passage thereof shall be published at least once in the Ross Valley Reporter,
(Name of Newspaper) a newspaper of general circulation, published and circulated in the City of San Anselmo
(Name of Public Agency) and thenceforth and thereafter the same shall be in full force and effect.

AMENDMENT TO CONTRACT BETWEEN THE
BOARD OF ADMINISTRATION
PUBLIC EMPLOYEES' RETIREMENT SYSTEM
AND THE
CITY COUNCIL
OF THE
CITY OF SAN ANSELMO

The Board of Administration, Public Employees' Retirement System, hereinafter referred to as Board, and the CITY COUNCIL of the CITY OF SAN ANSELMO, hereinafter referred to as Public Agency having entered into a contract under the date of April 24, 1959, effective July 1, 1959, and as amended effective January 1, 1964, November 1, 1966, December 1, 1968, December 1, 1972, and July 1, 1973, and as provided by Chapters 170 and 316, Statutes of 1971, which provide for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

A. The following subparagraph shall be added to Paragraph 8 of said contract:

8(d) "Local Policemen" shall include persons assigned to identification and communication duties in the Police Department who are not now local safety members and who were in such employment on August 4, 1972, who elect safety membership on or before September 28, 1973.

B. This amendment shall be attached to said contract and shall be effective on the 29th day of September.
