ORDINANCE NO. 710

ORDINANCE AMENDING THE SAN ANSELMO MUNICIPAL CODE TO PROVIDE
FOR A LIBRARY ADVISORY BOARD IN LIEU OF A BOARD OF LIBRARY
TRUSTEES

The Town Council of the Town of San Anselmo does ordain as follows:

Chapter 4 of Title 2 of the San Anselmo Municipal Code is hereby repealed and a new Chapter 4 entitled "Library Advisory Board" is enacted, to read as follows:

Section 2-4.01 - Advisory Board Created.

A Public Library Advisory Board is hereby established in and for the Town, to consist of five members, to serve without compensation.

Section 2-4.02 - Appointment and Term.

The members of the Board shall be appointed for staggered terms of four (4) years. The Library Trustees serving as of the effective date of this Chapter shall be the first members of the Board for the balance of their terms. A majority vote of all members of the Council shall be required to appoint a member of the Board or to fill any vacancy or to remove any member prior to the expiration of his term of office. Each member shall serve until his successor is appointed and qualified.

Section 2-4.03 - Organization and Meetings.

The Board shall organize and establish its meeting schedule as it sees fit. All meetings of the Board shall be public.

Section 2-4.04 - Functions.

Functions of the Board shall be:

1. To consider, propose and recommend guidelines with respect to programs and facilities to meet the library needs of the community. Such recommendations shall be made in conjunction with recommendations of the Town Librarian.
2. To review periodic reports from the Librarian concerning the general operations and functions of the Library.
3. To recommend ways of informing the residents of San Anselmo as to the programs, services and assistance which the Library affords, to solicit constructive comments from the community, and to encourage the development of innovative programs.

4. To promote intergovernmental cooperation in the development of Library services, patronage and usage.
5. To carry out such other functions as may be prescribed by the Council.

Section 2-4.05 - Gifts and Donations.

The Town shall receive any gifts, donations and bequests of library material, real property or money on behalf of the Board.
