

RESOLUTION DECLARING THE CANVASS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 13th 1954.

WHEREAS a General Municipal Election was held on the 13th day of April 1954, as required by law, and

WHEREAS it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made and declared in the time, form, and manner required by the Election Code of the State of California governing elections in cities of the sixth class, and,

WHEREAS the City Council of the Town of San Anselmo met at the council chambers in said Town of San Anselmo on Tuesday, the 20th day of April 1954, to canvass the returns of said election and to install the newly elected officers and as a result of which, the Council finds that the number of votes, the names of the persons voted for, and other matters required by law, to be as hereinafter stated,

NOW THEREFORE, be it resolved as follows: That the said General Municipal Election was held and conducted in the Town of San Anselmo on Tuesday, the 13th day of April, 1954, in the time, form, and manner as required by law, that there were six voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular Election precincts for holding state and county elections, as follows to-wit:

CONSOLIDATED VOTING PRECINCT "A", comprising State and County Precincts No. 217, 230, 231, 239, and the polling place thereof shall be Ongaro's Store, 243 San Anselmo Avenue.

CONSOLIDATED VOTING PRECINCT "B", comprising State and County Precincts No. 218, 219, 232, 243, and the polling place thereof shall be the City Hall, San Anselmo Avenue.

CONSOLIDATED VOTING PRECINCT "C", comprising State and County No. 233, 242, and the polling place thereof shall be Myers Roofing Serv. Co.

CONSOLIDATED VOTING PRECINCT "D", comprising State and County Precincts No. 216, 226, 234, 240, and the polling place thereof shall be Isabel Cook School. Sir Francis Drake Blvd.,

CONSOLIDATED VOTING PRECINCT "E", comprising State and County Precincts No. 220, 223, 224, 227, 228, 238, and the polling place thereof shall be Guglielmo Garage, 1401 San Anselmo Ave.

CONSOLIDATED VOTING PRECINCT "F", comprising State and County ~~Precincts 220, 223, 224, 227, 228, 238, and the polling place~~ Precincts 221, 222, 225, 229, 235, 236, 237, 241 and the polling place thereof shall be Dini's Garage, 125 Butterfield Road.

That the whole number of the votes cast in said Town of San Anselmo was \_\_\_\_\_; that the names of the persons voted for, the offices to be filled at said election, together with the whole number of votes which they received in the entire Town is as follows, to-wit:

Be it further resolved that at said General Municipal Election, Carmel Booth, George Washburn and Kenneth Ball were elected to the office of Councilman of the Town of San Anselmo for the full term of four years.

The Clerk of the Town of San Anselmo is hereby ordered, as required by law, to enter on the records of the City Council of the said Town, a statement of the result of said election, showing:

1. The whole number of the votes cast in the City.
2. The names of the persons voted for.
3. The measures voted upon.
4. For what office each person was voted for.
5. The number of votes given at each precinct to each person, and for and against each measure.
6. The number of votes given in the City to each person and for and against each measure.

The Clerk shall thereupon make and deliver to each of the persons elected a certificate of election signed by him and fully authenticated; he shall impose the constitutional oath of office and have each elected person subscribe his name thereto, whereupon each said elected person shall be inducted into the office to which he has been elected.
