RESOLUTION NO. <u>688</u>

RESOLUTION DECLARING THE CANVASS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 10th, 1956.

WHEREAS a General Municipal Election was held on the 10th day of April 1956, as required by law, and

WHEREAS it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made and declared in the time, form, and manner required by the Election Code of the State of California govering elections in cities of the sixth class, and,

WHEREAS the City Council of the City of San Anselmo met at the council chambers in said City of San Anselmo on Tuesday, the 17th day of April 1956, to canvass the returns of said election and to install the newly elected officers and as a result of which, the Council finds that the number of votes, the names of the persons voted for, and other matters required by law, to be as hereinafter stated,

NOW THEREFORE, be it resolved as follows: That the said General Municipal Election was held and conducted in the City of San Anselmo on Tuesday, the 10th day of April, 1956, in the time, form, and manner as required by law, that there were six voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular election precincts for holding state and county elections, as follows to-wit:

CONSOLIDATED VOTING PRECINCT "A", comprising State and County Precincts Nos. 230,231,239,245,246, and the polling place thereof shall be Wade Thomas School, 115 Kensington Road.

CONSOLIDATED VOTING PRECINCT "B", comprising State and County Precincts 232,243,244, and the polling place thereof shall be the City Hall, San Anselmo.

CONSOLIDATED VOTING PRECINCTS "C", comprising State and County Precincts Nos. 233,242,247, and the polling place thereof shall be Myers Roofing Service Co., 201 Redhill Avenue.

CONSOLIDATED PRECINCT "D", comprising State and County Precincts Nos. 225, 226, 227, 234, 235, 240, and the polling place thereof shall be Isabel Cook School, 1000 Sir Francis Drake Blvd.,

CONSOLIDATED PRECINCT "E" comprising State and County Precincts
Nos. 220,223,224,228,238, and the polling place thereof shall be
Struckman Garage, 1311 San Anselmo Avenue.

CONSOLIDATED PRECINCTS "F", comprising State and County Precincts Nos. 221, 222,229,236,237,241 and the polling place thereof shall be Brookside School, Mrookmead Court.

Thompson was elected to the office of Treasurer of the said City of San Anselmo for a term of four years. Anita U. Gannon was elected to the office of City Clerk for a full term of four years.

The Clerk of the City of San Anselmo is hereby ordered, as required by law, to enter on the records of the City Council of said City, a statement of the result of said election, showing:

- 1. The whole number of the wotes cast in the City.
- 2. The names of the persons voted for.
- 3. The measures voted upon.
- 4. For what office each person was voted for.
- 5. The number of votes given at each precinct to each person, and for and against each measure.
- 6. The number of votes given in the City to each person and for and against each measure.

The Clerk shall thereupon make and deliver to each of the persons elected a certificate of election signed by him and fully authenticated; he shall impose the constitutional oath of office and have each lelected person subscribe his name thereto, whereupon each said elected person shall be inducted into the office to which he has been elected.
