

RESOLUTION NO. 906

RESOLUTION DECLARING THE CANVASS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 10th 1962.

WHEREAS a General Municipal Election was held on the 10th day of April 1962, as required by law, and

WHEREAS it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made and declared in the time, form, and manner required by the Election Code of the State of California governing elections in General Law cities, and,

WHEREAS the City Council of the City of San Anselmo met at the council chambers in said City of San Anselmo on Tuesday, the 17th day of April 1962, to canvass the returns of said election and to install the newly elected officers and as a result of which, the Council finds that the number of votes, the names of the persons voted for, and other matters required by law, to be as hereinafter stated,

NOW THEREFORE, be it resolved as follows: That the said General Municipal Election was held and conducted in the City of San Anselmo on Tuesday, the 10th day of April 1962, in the time, form, and manner as required by law, that there were six voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular election precincts for holding state and county elections, as follows to-wit:

CONSOLIDATED VOTING PRECINCTS "A", comprising State and County Precincts Nos. 2230, 2231, 2239, 2245, 2246, and the polling place thereof shall be Wade Thomas School

CONSOLIDATED VOTING PRECINCTS "B", comprising State and County Precincts Nos. 2232, 2243, 2244, and the polling place thereof shall be the City Hall.

CONSOLIDATED VOTING PRECINCTS "C", comprising State and County Precincts Nos. 2233, 2242, 2247, and the polling place thereof shall be 216 Greenfield Ave.

CONSOLIDATED VOTING PRECINCT "D", comprising State and County Precincts Nos. 2225, 2226, 2227, 2234, 2235, 2240, and the polling place thereof shall be Isabel Cook School

CONSOLIDATED VOTING PRECINCTS "E", comprising State and County Precincts Nos. 2224, 2228, 2238, 2248, 2252, and the polling place thereof shall be Yolandsdale School

CONSOLIDATED VOTING PRECINCT "F", comprising State and County Precincts Nos. 2229, 2236, 2237, 2241, 2249, 2250, 2251, and the polling place thereof shall be Brookside School.
