RESOLUTION NO. 997

RESOLVED by the City Council of the City of San Anselmo that a General Municipal Election will be held in the City of San Anselmo on Tuesday, the 14th day of April 1964 for the purpose of electing the following officers:

Two Councilmen for the full term of four years.

One City Treasurer for the full term of four years.

One City Clerk for the full term of four years.

BE IT FURTHER RESOLVED, there will be six voting precincts for the purpose of holding said election, which precincts shall be consolidates of the regular precincts for holding State and County elections, and shall be as follows:

CONSOLIDATED PRECINCT NO. 1 comprising State and County Precincts Nos. 2230, 2239, 2245, 2246, and the polling place thereof shall be Wade Thomas School, 115 Kensington Road.

CONSOLIDATED PRECINCT NO. 2 comprising State and County Precincts Nos. 2231, 2232, 2243, 2244, and the polling place thereof shall be the City Hall, San Anselmo Avenue.

CONSOLIDATED PRECINCT NO. 3 comprising State and County Precincts Nos. 2233, 2242, 2247, and the polling place thereof shall be Redwood Moving & Storage, 230 Greenfield Avenue.

CONSOLIDATED PRECINCT No. 4 comprising State and County Precincts Nos. 2225, 2226, 2227, 2234, 2235, 2240, and the polling place thereof shall be Isabel Cook School, 1000 Sir Francis Drake Blvd.

CONSOLIDATED PRECINCT NO. 5 comprising State and County Precincts Nos. 2224, 2228, 2238, and the polling place thereof shall be Yolansdale School, 1365 San Anselmo Avenue.

CONSOLIDATED PRECINCT NO. 6 comprising State and County Precincts Nos. 2229, 2236, 2237, 2241, 2249, 2250, 2251, and the polling place thereof shall be Brookside School, Butterfield Road.
