EMPLOYMENT CONTRACT

THIS AGREEMENT made this 28 day of March, 1967, by and between the CITY OF SAN ANSELMO, a municipal corporation of the sixth class, hereinafter referred to as "City", and A. C. KAEPPEL, hereinafter referred to as "Controller",

W I T N E S S E T H:

WHEREAS, Controller for some time past has been employed by the City as "Controller" by appointment of the City Council of San Anselmo to serve at the pleasure of the City, and

WHEREAS, Controller, in addition to his other duties, has been appointed Chief Administrative Officer, and

WHEREAS, City is aware that Controller has executed the duties of his office of Controller in a superior manner and to assure the benefit to City of Controller's experience and skills it is highly desirable that there be orderly continuity in the office of Controller and that he be given certain assured tenure in his position of Controller all to the best interests and welfare of City, and

WHEREAS, Controller has agreed to assume the duties of Chief Administrative officer, in addition to his other duties, upon assurance that he would have the benefit of reasonable tenure in his position of Controller,

THEREFORE, it is agreed that City hereby employs Controller, to perform and execute the duties of that office, for a term of four (4) years commencing April 1st, 1967 and expiring four (4) years thereafter. That the starting salary shall be the same as Controller receives for that position

and hereafter the salary shall, from time to time, be adjusted as the City Council deems fit and proper but in no event less than the present salary unless any proposed salary reduction is part of a general salary reduction effecting all employees of the City.
