

RESOLUTION NO. 1201

RESOLUTION DECLARING THE CANVAS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL ELECTION HELD ON APRIL 9, 1968.

WHEREAS, A General Municipal Election was held on the 9th day of April 1968, as required by law, and

WHEREAS, it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made and declared in the time, form, and manner required by the Election Code of the State of California governing elections in General Law Cities, and

WHEREAS, the City Council of the City of San Anselmo met at the council chambers in said City on Tuesday, the 16th day of April 1968, to canvass the returns of said election and to install the newly elected officers and as a result of said election the City Council finds that the number of votes, the names of the persons voted for, and other matters required by law, to be as hereinafter stated,

NOW THEREFORE, BE IT RESOLVED as follows: That the said General Municipal Election was held and conducted in the City of San Anselmo on Tuesday, the 9th day of April 1968, in the time, form, and manner as required by law, that there were seven voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular election precincts for holding State and County elections, as follows to-wit:

CONSOLIDATED PRECINCT 2005 comprising State and County Precincts Nos. 2200, 2203, and the polling place was Aquilino Garage, 5 Jordan Avenue.

CONSOLIDATED PRECINCT 2006 comprising State and County Precincts Nos. 2202, 2204, 2205, and the polling place was the City Hall.

CONSOLIDATED PRECINCT 2007 comprising State and County Precincts Nos. 2201, and the polling place was Wade Thomas School.

CONSOLIDATED PRECINCT 2008 comprising State and County Precincts Nos. 2206, 2207, 2208, and the polling place was Yolansdale School.


CONSOLIDATED PRECINCT 2009 comprising State and County Precincts Nos. 2209, 2212, 2213, and the polling place was Brookside School.

CONSOLIDATED PRECINCT 2010 comprising State and County Precincts Nos. 2210, 2211, and the polling place was San Anselmo Fire Station #2.

CONSOLIDATED PRECINCT 2011 comprising State and County Precincts Nos. 2214, 2215, and the polling place was Isabel Cook School.
