A RESOLUTION REQUESTING A CITY OF SAN ANSELMO SPECIAL ELECTION TO BE CONSOLIDATED WITH THE GENERAL ELECTION TO BE HELD ON NOVEMBER 3, 1970, AND SETTING FORTH CERTAIN CITY PROPOSITIONS TO APPEAR ON THE BALLOT.

Good cause appearing therefor, the City Council of the City of San Anselmo resolve as follows:

Pursuant to section 23302 of the Elections Code of the State of California the City Council of the City of San Anselmo requests that a Special City Election be consolidated with the General Election to be held on November 3, 1970, and that the following City propositions shall appear on the ballot.

First Proposition: Shall the City of San Anselmo purchase a new fire engine including its necessary related apparatus and equipment at a cost of FIFTY-TWO THOUSAND (\$52,000.00) DOLLARS by levying a special tax, pursuant to Government Code section 43225, of nine cents (.09) on each one hundred dollars (\$100) on the property assessed for purposes of taxation within the City for the two fiscal years of 1971-1972 and 1972-1973.

Second Proposition: Shall the City of San Anselmo undertake the reconstruction and upgrading of accepted City streets which have been found to be dangerously defective (as shown by the report of the Director of Public Works) at a total cost of FIFTY-TWO THOUSAND (\$52,000.00) DOLLARS by levying a special tax, pursuant to Government Code section 43225, of nine cents (.09) on each one hundred dollars (\$100.00) on the property assessed for purposes of taxation within

the City for the two (2) fiscal years 1971-1972 and 1972-1973.

Third Proposition: Shall the present salaries of each of the San Anselmo City Councilmen of TWENTY-FIVE (\$25.00) DOLLARS per each monthly meeting attended with a maximum of SEVENTY-FIVE (\$75.00) DOLLARS per month be reduced so as to limit the monthly salary to a maximum of FIFTY (\$50.00) DOLLARS.
