RESOLUTION NO. 1505

RESOLUTION DECLARING THE CANVASS OF RETURNS AND RESULTS OF GENERAL MUNICIPAL ELECTION
HELD ON MARCH 5, 1974.

WHEREAS, a General Municipal Election was held on the 5th. day of March, 1974, as required by law, and

WHEREAS, it appears that notice of said election was duly and legally given as required by law, and voting precincts were properly established; that election officials were duly appointed and served and election supplies furnished and that in all respects said election was held and conducted and the votes thereat received and canvassed and the returns thereof made, and declared in the time, form, and manner required by the Election Code of the State of California governing elections in General Law Cities, and

WHEREAS, the City Council of the City of San Anselmo met at the Council chambers in said City on Tuesday, the 12th. day of March, 1974, to canvass the return of said election and to install the newly elected officers and as a result of said election the City Council finds that the number of votes, the names of persons voted for, and other matters required by law, to be as hereinafter stated,

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS: That the said General Municipal Election was held and conducted in the City of San Anselmo on Tuesday, the 5th. day of March, 1974, in the time, form, and manner as required by law, there were nine voting precincts established for the purpose of holding said election, consisting of a consolidation of the regular election precincts for holding State and County elections, as follows to-wit:

CONSOLIDATED PRECINCT 2001 comprising State and County Precincts Nos. 2200, 2203 and the polling place was the Krahl Residence, 60 Sequoia.

CONSOLIDATED PRECINCT 2002 comprising State and County Precincts Nos. 2201, 2202 and the polling place was the St. Anselm's Gym, Corner of Richmond Rd. and Mariposa Avenue.

CONSOLIDATED PRECINCT 2003 comprising State and County Precincts Nos. 2204, 2205 and the polling place was Ongaro Plumbing, 243 San Anselmo Avenue.

CONSOLIDATED PRECINCT 2004 comprising State and County Precincts Nos. 2206, 2216 and the polling place was San Anselmo City Hall, 525 San Anselmo Avenue.

CONSOLIDATED PRECINCT 2005 comprising State and County Precinct 2207 and the polling place was the Gillis Residence, 33 Scenic Avenue.

CONSOLIDATED PRECINCT 2006 comprising State and County Precincts Nos. 2208, 2209 and the polling place was the Nazarene Church, 1509 Sir Francis Drake Blvd.

CONSOLIDATED PRECINCT 2007 comprising State and County Precincts Nos. 2210, 2211 and the polling place was San Anselmo Fire Station #2, Arroyo and Butterfield Rd.

CONSOLIDATED PRECINCT 2008 comprising State and County Precincts Nos. 2212, 2213 and the polling place was Brookside School, Butterfield Road.

CONSOLIDATED PRECINCT 2009 comprising State and County Precinct Nos. 2214, 2215 and the polling place was Isabel Cook School, 1000 Sir Francis Drake Blvd.
