RESOLUTION NO. 189.5

A RESOLUTION OF THE TOWN COUNCIL OF SAN ANSELMO APPROVING THE FIVE-YEAR FEDERAL-AID URBAN PROGRAM BEGINNING 1982-83 RECOMMENDED BY THE MARIN COUNTY URBAN SYSTEM COMMITTEE

WHEREAS, the Town of San Anselmo desires to continue to participate in the Federal-Aid Urban Program for funding approved transportation projects as authorized by the Federal Highway Act of 1973 and succeeding amendments, and

WHEREAS, the Federal Highway Act, the State Transportation Board and the Metropolitan Transportation Commission require that a program of projects approved for Federal-Aid Urban funding, be established by a County-wide Committee consisting of representatives from each City, the County, Transit District, California Department of Transportation, Golden Gate Bridge District, and the Metropolitan Transportation Commission, and

WHEREAS, the Marin County Board of Supervisors has approved procedures for the Federal-Aid Urban Program and the formation of the Marin County Urban System Committee, and

WHEREAS, the Marin County Urban System Committee did meet to review the program and new projects which had been submitted for consideration as part of a five-year program, and

WHEREAS, the Marin County Urban System Committee did approve a five-year Federal-Aid Urban Program on December 2, 1981.

NOW, THEREFORE, BE IT RESOLVED that the San Anselmo Town Council does hereby approve the five-year Federal-Aid Urban Program of projects beginning 1982-83 recommended by the Marin County Urban System Committee as specified in Exhibit A attached hereto.

BE IT FURTHER RESOLVED that copy of this Resolution be forwarded to the Board of Supervisors of the County of Marin for approval as the Marin County Federal-Aid Urban System Program for 1982-83.
