A RESOLUTION ADOPTING THE ATTACHED MUNICIPAL COURT CITATION
BAIL SCHEDULE AND DESIGNATING CERTAIN EMPLOYEES TO
EXERCISE CITATION AUTHORITY, INCLUDING ARREST

BE IT RESOLVED By the Council of the Town of San Anselmo as follows:

WHEREAS, the Town Council has established a citation program in order to facilitate compliance with local codes, ordinances and regulations; and

WHEREAS, the citation ordinance requires the adoption of a bail schedule prior to the implementation thereof; and

WHEREAS, the citation ordinance requires prior approval of the bail schedule by the Municipal Court; and

WHEREAS, the citation ordinance also requires that the Council designate certain employees to exercise arrest and citation authority.

NOW, THEREFORE, BE IT RESOLVED by the Council and the Town of San Anselmo that, pursuant to Ordinance No. 867 of the Town of San Anselmo, the bail schedule attached hereto, marked Exhibit "A", is hereby incorporated as a part of this resolution, and is hereby adopted; and

RESOLVED, FURTHER, that the bail schedule attached hereto, marked Exhibit "A" has been approved by the Municipal Court; and

RESOLVED, FURTHER, that the Director of Public Works or his/her designated representative is hereby authorized to exercise arrest and citation authority under this ordinance.
